Please be informed that my clients, Sri. Ravi Kumar Reddy and 4 others had filed the subject mentioned SOP to declare the Election conducted on 27-06-2023 as illegal, null and void and along with the same, they had also preferred an IA No. 1033 of 2023 seeking an interim injunction, restraining the conduct of the General Body meeting dt. 15-07-2023 of the first of you, pending the disposal of the SOP and in the same, the Hon'ble Court was pleased to pass an order of Status Quo vide order dated 14-07-2023 and the copy of the said order is awaited and will be furnished as and when the same is made ready.

You are hereby informed that the conduct of the General Body Meeting dated 15-07-2023 by the first of you would be in contravention of the said order and any violation of the same would invite further prosecution.
