## SUSPENSION OF ELECTION RESULTS OF NORTHERN REGION

Greetings from the Executive Committee of IIA Haryana Chapter.

In view of the results of the online voting declared on 30 Dec 2023, for IIA's Five Regional Representative to Council of Architecture for the term 2023-26, the Executive Committee of IIA Haryana Chapter held an Emergency Meeting today at Faridabad and has unanimously resolved to submit the following for your immediate attention and action in the matter:-

- The 14 numbers of votes polled in Haryana for Ar. Punit Sethi, candidate for is a clear indicator of an erroneous voting system and warrant an immediate inquiry/investigation into the voting module, and (in the interim) the suspension of results declared on 30 Dec 2023.
- The results are unfair and unjust to the Members of IIA Haryana Chapter, who 2. believed in the voting system and voted accordingly. This system clearly paints a poor picture of the IIA Council which is responsible for running the affairs of the Institute.

In light of the above we request you to immediately suspend the results of the Northern Region and conduct enquiry/investigation into the flaw with the election module. It is further brought to your notice that in case this action is not taken IIA Haryana Chapter shall not participate in any National event of the Institute.
